Town voters to choose one of three for mayor, cast ballots for councilmen on Monday, April 17

Hancock residents who are registered to vote will choose from three candidates for mayor and two candidates for Hancock council on Monday, April 17 during the town's municipal election.

Voting booths open at 11 a.m. at Town Hall and remain open until 7 p.m.

Mayor Tim Smith is running for re-election and is opposed by Councilman Roland Lanehart Jr. and resident Preston Hall.

Hancock's mayors are elected for two-year terms. Smith, a longtime councilman, is serving out his first term as mayor.

Lanehart's first term as councilman is running out as well. Instead of seeking reelection to his council seat, Lanehart sets his sights on the mayor's chair in this election.

Preston Hall has been a perennial mayor candidate for the last few elections.

Councilman Josh Mc-Cusker is seeking his first elected term on Hancock council in this election. Mc-Cusker was appointed to his seat in 2021.

Resident Richard Strong is vying for one of two open council seats.





Hancock Arts Council, where she gave an impressive performance of the Brahms Hungarian Rhapsody #5 on the marimba.



Preparing for a transport disaster, Part I: How is Hancock positioned to handle train or truck emergencies?

In 2023, train derailments, toxic spills and other transport-related emergencies have been making headlines across the country. The most notable incident was a train derailment in East Palestine, Ohio which spilled a variety of toxic chemicals, and resulted in a fire that evacuated the immediate area for public safety. More recently, a tanker truck carrying 8,650 gallons of gasoline crashed in a fiery explosion in Frederick, causing the death of the driver and extensive property damage.

What if something like either of those happened in Hancock or across the Potomac River on the train tracks?

Hancock News The reached out to first responders and government offi-

cials to find out what the response would be. In Part I, this reporting will look at how local first responders would handle the calls.

Hancock Fire Company and Hancock Rescue Squad would be the first to respond to such an incident in the vicinity of town.

Fire Chief Robert Hoopengardner said in an email he isn't sure exactly what units would be dispatched for a train derailment as it would depend on what the caller reported was involved.

If the caller reported an Amtrak train derailed, it would trigger certain units to be dispatched to respond, versus a caller saying a cargo train derailed and a large cloud was visible around the crash site.

Because of the location of

the train tracks, Morgan County, W.Va. units would be dispatched to respond.

Hoopengardner said on a call like this, Hancock or Morgan County would arrive on scene and immediately setup incident command.

"We have and always will work closely with our neighboring first responders in Morgan County," he said.

Command would then decide if an evacuation would be needed or the public could shelter in place.

That could depend on what cargo trains were carrying through the area, if chemicals are toxic in an airborne form or how chemicals on trains might interact if released from their individual trains.

This occurred at each stop – Rev. James Mason, Deacon at St. Peter's, read and reflected at Martha's House;



Dear EarthTalk:

Is it really bad for the planet to upgrade my phone every two years?

Smartphones have certainly become ubiquitous, with some 85% of Americans and 67% of adults worldwide possessing one. Manufacturers sell almost 1.5 billion of them per year. And every year these manufacturers come out with upgraded models to lure customers into trading in their old models to get the latest technology at their fingertips. According to the Consumer Electronic Association the average lifespan of a smartphone is 4.7 years, but the average American user replaces their smartphone within three years. This can be, in part, attributed to planned obsolescence by manufacturers. As new smartphones are manufactured, new software updates accompany them; these updates can lead to older phones becoming unusable if they do not have the capacity to accommodate the new software.

Regarding pollution created by the industry, 95% of emissions come from the production phase. A culture that requires constant replacements results in ongoing growth of manufacturing emissions. In addition, continuously replacing phones creates e-waste in the form of the phones themselves. In 2019, 50 million tons of waste came from smartphones which constitute about 10% of e-waste globally.

One way to combat e-waste is to recycle. However, according to the World Economic Forum, only about 20% of global e-waste is recycled. The Basel Action Network used radio tracking to verify where shipments of e-waste were sent. They found that nearly 40% of e-waste from the United States was exported illegally to developing nations where it was unsafely processed or even burned in the open air.

There are steps manufacturers can take to alleviate the environmental burden, one being to introduce "repairable" phones. Currently manufacturers hamper smartphone repair with very high repair prices and restricting third parties from having access to the needed parts. Europe is leading the charge on embracing a circular economy surrounding smartphones that encourages repairs, refurbishments and upgrades instead of replacement. Various European countries have instituted programs to address the problem. France maintains a publicly accessible phone repairability index to help consumers there make smart choices about their smartphone purchases. Meanwhile, Sweden and Austria both offer financial incentives for device repairs to encourage fixing instead of junking old smartphones and other electronics. Whether or not such programs exist in your neck of the woods, you can be part of the solution by simply waiting longer to upgrade your phone, which will help reduce the demand on production while lowering your environmental footprint. While it may not seem like much at first glance, keeping your phone for an extra year can reduce your lifetime device usage by 25%. When it is finally time to get a new phone, an eco-conscious consumer can turn to companies like Fairphone and SHIFT that offer easily changeable parts and support software upgrades throughout the phone's lifespan. 

Resurrection: Ongoing? "Mystic Consciousness"...

"I want to know Christ and the power of the resurrection" (Phil. 3:10).

Okay, His Resurrection is ongoing, communicable--Huh?

Just like, Spring, Resurrection is both a verb and ongoing. We say--and see Spring--springing (thus, a verb, active and lively) it's an ongoing season. Kinda' likewise, for Catholics, we celebrate Easter for fifty days, until Pentecost, the Coming of the holy Spirit-Fire upon the apostles (Acts.2) We didn't just fast (Mt. 6), confess (Jas. 5:16) and alms give (Mt. 6) for 40 days to forget and drop Easter so quickly. Question is: Do you have and call upon The Spirit? Look, we're so used to "treadmill time" and earthly consciousness--sequential, day after boring day, kinda like a flatline from 1 to 10, with no relation to Heaven or other "realms". But there is "another realm" and Reality--God in His Heaven and Eternal Now (Latin, "nunc stans"), and wherein all things, time and history, and Haven are in a successionless Present to Him, perfectly co-existing and manifested. Now Eternal Bliss as, opposite our normal, everyday flat-line time; Visualize Eternity as a circle, or, better yet: a spiritual-sphere, a mystical globe (Catholics sometimes describe it as Mystical Body and Life). Now, most Christians, don't image or think these two Ways or frameworks, the line and sphere, go together, but they do. Now visualize the flatline, no longer separate or under the sphere (separate) but rather see, (feel!) the line (daily life) going thru, interpenetrating the spiritual-sphere. So: "Total Reality"f is both flatline (we--and the Incarnational Jesus-experience sequences and repetitions and unfolding history) but, also, an sometimes sense interaction with Eternity and an-other Reality. Even Jews believe this: "The Lord has placed eternity in our hearts" (Eccles. 3:11), and the whole Book of Revelation is a "mystical report" of the porousness between Heaven and Earth. So, now, when we have this new kind of "mystical consciousness" (spiritually synergizing the flatline and the sphere---"by a renewal of the Spirit" (Rm. 12:2) --we always can relate to God, Heaven and, also, tap into the Eternal Now of His Grace, such as the Resurrection. Jesus "interrupts" (makes porous) that "flatline suffocation nature" to expose Eternity and, better, nowness of Christ's Resurrection, when He says to Mary, even before it historically happens!: "I AM the Resurrection and the Life" (Jn. 11:25)... So, upshot, practice "The ABC's of Resurrection Renewal": A= Awareness of the spiritual-spherical-eternal world penetrating daily life. See Acts 22:7, where The Crucified and Resurrected Jesus speaks to Paul, in his flatline life-Road to Damascus. Access Eternity now!. B= Blur (make porous, by meditation-realization) the illusory and stifling walls supposedly separating you and God and Resurrection and Eternal Now-ness: "But we have the mind of Christ' (I Cor. 2:16). C= Consciously conjoin with Christ's Resurrection Light and Glory, as St. Paul states: "For if we have been united with Him like this in His death, we will certainly also be united with Him in His resurrection" (Rm 6: 5). Hook into, love, luxuriate in The Eternal "I AM" of Jesus' Resurrection now, manana and forever! And enjoy the Manifestation-theophany all around us, Springing!





The seventh inning stretch is a time-honored tradition in professional baseball when fans have a chance to stand and stretch, cheering on their winning team halfway through the game's final inning.


That chance was narrowly missed for Panthers fans last week, when the Hancock High School boys' varsity baseball team lost to two different rivals in the final inning of each non-conference game.

Spring brings greater risk of wildfire in Maryland

begun in Maryland, and the Maryland Department of Natural Resources urges residents across the state to prepare and help prevent wildfires.

Wildfire occurrence is highest in the spring and fall when forest fuels are the driest and weather conditions warm, dry, and windy - are most conducive for the spread of fire.

The department works closely with the National Weather Service to notify citizens on days when this threat is most likely.

Each year, the Maryland Forest Service responds to an average of 122 wildland fires that burn 1,050 acres of forest, brush, and grasses.

The Department of Natural Resources also helps equip and train Maryland's local volunteer fire companies to combat wildland fires through its Volunteer Fire Assistance Program.

The leading unintentional cause of wildfires in Maryland is burning of debris or any kind of outdoor burning, which on a 10-year average accounts for 34% of the fires to which the Maryland Forest Service responds.

The second-leading cause is arson, followed by several

Spring wildfire season has other man-made causes such as heat or sparks from equipment use. Lightning is the only natural source of fire ignition, but accounts for only 3% of fire starts.

> The Maryland Forest Service recommends alternatives that are safer and more environmentally friendly than

> outdoor debris burning - including composting or mulching of yard waste, leaves and brush, and using larger brush or trees for firewood.


Outdoor burning should only be done on low fire danger days. State regulations apply to activities in or within 200 feet of woodland, or activities adjacent to or within an area where flammable materials are located.

Open air burning is only allowed if:

-There is a natural or constructed fire break at least 10 feet wide completely around the material to be burned that is free of flammable materials:

-Adequate personnel and equipment are present to prevent the fire from escaping;

-At least one responsible person remains at the location of the fire until the last spark is out; and



-Burning occurs between the hours of 4 p.m. and midnight unless the ground is covered with snow.

Morgan County Office of Emergency Services (OES) Director Jason Hoover has said the county's first step would be to contact CSX or the appropriate rail company to verify the contents of rail cars and tap their expert resources in how to respond to any spill or fire.

Morgan County fire and EMS units have the same training as Hancock agencies, and would work to coordinate their response through Emergency Services managers, who can request equipment, staffing and expertise from their respective states and national emergency agencies. How does evacuation work?

He gave an example of a tanker crashing on the I-70 bridge over Pennsylvania Avenue with the same scenario as Frederick.

Hoopengardner said units would arrive on scene and set up a command post and request additional resources from other companies while attempting to extinguish the fire - Hazmat, Town of Hancock, state roads, MDE, and activate the Emergency Operations Center (EOC).

"We would then request the police department evacuate Pennsylvania Avenue from Resley Street to High Street and have the 911 center send a text out over Everbridge of an immediate evacuation of that area," Hoopengarder said.

scene as there will more than likely be multiple patients, so it would be mitigated with the second unit and as much manpower as possible.

Barnhart said the type of incident and injuries would dictate where patients might go for treatment.

Each railcar or tanker has a placard alerting first responders and others what is being transported in the containers and there is a guidebook first responders have that would also help in determining where the patients go for treatment or if there needs to be an evacuation or shelter in place issued.

Barnhart said if somebody were exposed to chemicals, they would get treatment at Meritus in Hagerstown if possible, as they have a decontamination unit and could handle the number of possible patients. It's also a level three trauma center.


Agencies recommend each household has an emergency kit ready in case of such events.


Depending on what's involved, command could shut down U.S. 522 in Maryland at the bridge initially and in West Virginia near Lover's Leap, River Road at Culp Road, Pious Ridge at River Road, and Fairview Drive at River Road for a train derailment.

"Doing this shuts down access to the crash site," he said.

When asked how the public could keep themselves safe if there was a tanker explosion, Hoopengarder admitted it wasn't an easy question to answer because it depends on the type of call.

If it was like Frederick, Hoopengardner said people would need to get away from the area involved in the fire.





evacuated, command would be in contact with the Division of Emergency Services in Washington County and have them send a text out on Everbridge to the community and also request the assistance of the police department to make announcements on a PA system while driving through the community, and if needed go door to door," Hoopengardner said.

He added they would also send personnel to the airport to make sure they are evacuated as well.

With the train yard being close to the 522 bridge, there is the possibility the crossing over the Potomac would be closed, too.

Hoopengarder said once command had evaluated the incident and decided the road would need shut down, they would have dispatch contact MDOT and West Virginia Division of Highways to shut down U.S. 522.

With the Hancock area being at the crossroads for four roads - US 522, US 40/MD144, I-68, and I-70 there are tanker trucks hauling gasoline and other chemicals through the area at all times.

In the Frederick incident, the tractor-trailer was loaded with gasoline when it wrecked, causing damage to the tanker and allowing the gasoline to spill onto the ground and catch fire, the fire chief said. The fuel spread as it continued to spill out.

'We have too many possible scenarios here where we live because of all the interstates to try and say what we

He added there would be a request for a foam unit to help extinguish the fire from Hagerstown Regional Airport and Martinsburg Airport.

"We would try and contain the spill to that area," Hoopengardner said.

He noted firefighters in Hancock don't train enough for these situations and they have their initial training and reading materials through the year.

Chief Stephen Barnhart of the Hancock Rescue Squad said Company 59 would respond with their heavy rescue squad that has a lot of specialty equipment to assist the fire department with absorbents if there are leaks, and damming or diking to help with water control.

There are also pads that could divert whatever chemicals are going into streams and storm drains.

Barnhart also said they'd respond with manpower to assist the fire department with putting out any fire as well, including mitigation of any chemicals. He added there are rescue techs that would be available.

Hancock Rescue would be at the direction of command and more than likely be the first EMS response to be on scene taking care of any patients who might be injured or exposed to anything.

"Our primary role first, as far as the EMS side of it, would be take care of any critically injured or sick people from any hazardous material that may have come about," Barnhart said.

Hancock has two medic units available at the station

If a patient isn't stable, they would go to War Memorial. Hospital, which is much closer.

Should there be an evacuation situation, Hancock Rescue Squad would assist and could assist with some of their utility vehicles if there was a mass evacuation due to whatever chemical possibly floating in the air.

Barnhart said if they had to evacuate for a possible twomile radius, they would have to see what manpower they could pull together to assist the fire department.

In that situation though, Barnhart said they'd also be pulling resources from other parts of Washington County as well, along with the major role police would play as well

Safety of bystanders

With people looking to get "likes" and other forms of social media affirmation, there will bound to be onlookers looking to get a closer look at major emergency sites.

Hoopengardner said if people know what's going on, they should stay inside their homes until an evacuation order is issued because it could be decided that a shelter in place could be issued instead of being evacuated.

Should the evacuation order be given, Hoopengardner said people should only take with them what's necessary for a couple days like medications, clothes for a couple days, cash, and credit cards.

"If I lived where Harry's store used to be [on Pennsylvania Avenue], I would walk out the back door and walk towards Virginia Ave.," Hoopengardner said.

If it's a train derailment with a hazardous substance leaking and the wind carrying it over Hancock and no evacuation order given, Hoopengarder said people should shelter in place. That means bringing family and pets inside; locking doors and closing windows, air vents, and fireplace dampers; and turning off fans, air conditioners, and force heating systems.

"If you know of an emergency, listen to local media for updates and what you may need to do," he said. "Do not try and see what's going on."

Hoopengarder added people should listen to firefighters, EMS, and/or police when they tell you to either evacuate or shelter in place.

"Remember we only do this when it is absolutely necessary to keep you safe," he said.

Barnhart added if there were to be a large-scale incident and there were not an immediate threat to a person, he would strongly suggest a shelter in place until instructed otherwise.

"Shelter in place is probably the best thing until you hear otherwise and just monitor local TV channels and radio channels," he said.

Eric Jacobs, Washington County's Division of Emergency Services Operations Manager, said generally an

incident like a train derailment would require a great deal of command, control, and communications.

"Washington

through Emergency Management, would be charged with updating the general public on potential risks and known County, evacuations," he said.
