

There will be craft vendors, food vendors, nonprofit organizations, churches, live music, and a great time, organizers said.

The first came in November 2019 when Hancock in Motion announced during the town meeting they were planning one for June 2020. The COVID-19 pandemic put that event on hold.

The second revival attempt was at the December town meeting that same year when then Town Manager Joe Gilbert said a res-

Questions & Answers About Our Environment

Dear EarthTalk:

What are some examples of citizen science in efforts to monitor and combat global warming?

-Candace C., Tallahassee, FL

The world is getting warmer each year, and people worldwide want to do their bit to help. Many of us already are. We turn thermostats, bike to get around, recycle and urge elected officials to make our cities greener. But there is one more thing any of us can do to fight global warming: it's called citizen science.

Citizen science is the involvement of the general public you, your communities, anyone who is not a professional scientist—in collecting data to support scientific research. Citizen science has actually existed for decades. For example, the National Audubon Society's Christmas Bird Count began in 1900 to promote conservation. With the gigantic leap in 21st century technology, citizen science is now truly invaluable in dealing with the climate crisis. Ordinary people can record and share vast amounts of data on smartphones, and identify thousands of animal and plant species through apps. They can even connect from remote places to share information about the effects of global warming on their local ecosys-

In citizen science there's something for everyone. Those concerned about climate can record the timing of flowering for Project Budburst. Those interested in oceans can monitor beach debris for the Coastal Observation and Seabird Survey Team (COASST), which studies how global warming has hurt coastal ecosystems and their wildlife inhabitants. By listening to frog calls for the North American Amphibian Monitoring Program (NAAMP), recording glacial melts in rural Alaska for the Indigenous Sentinels Network, or photographing mountain smog for the Appalachian Mountain Club, citizen scientists provide valuable data from all over the world that scientists couldn't otherwise obtain.

With climate change a worldwide concern, citizen science, too, is a global phenomenon, especially useful in poor or remote areas where accurate meteorological data are hard to come by. In such places, citizen scientists are the best way to collect data useful for local needs. In Bangladesh, farmers record temperature and humidity for the Transforming Climate Knowledge with and for Society (TRACKS) project to monitor how global warming harms the crops upon which they depend. In South Africa, villagers collect data on needed groundwater supplies via the Diamonds on the Soles of their Feet project.

Another promising aspect of citizen science is that it is being integrated into school curricula, introducing students worldwide to standardized measurements of climate change. Through Global Learning and Observations to Benefit the Environment (GLOBE), citizen scientist students have collected data to study how climate change has affected the earth's energy balance and the spread of mosquito-borne diseases.

Regardless of location, age or nationality, citizen scientists are heroes in the worldwide effort to combat global warming. There is a wealth of information online that can help anyone find citizen science projects by location and project type so that they can get involved. SciStarter.org or CitizenScience.gov are good places to start the search.







Jesus even implies further changes and revelations in the afterlife of our own resurrection (God willing) where we will be like angels (Mt. 22:30). Hmmm, still more becoming!

While we are made in God's Image, and as male and female (Gn. 1:27) there is room to explore, but not exploit--our true selves and bodies. If you are ever confused, always remember you are a child of God (Jn. 1:12). You are called to be a saint (I Cor. 1:2) and you are complete in Christ, as we "have come to fullness in Him" (Col. 2:10). The world is trying to mess with you and confuse you, so always remember, as God created you at birth, male or female, that "you are God's "temple and the Holy Spirit dwells within you" (I Cor. 3:16). Everyone is gonna have troubles and even depressions in their self-becoming, but always remember: As I just performed a baptism I anointed the baby--and we all were, hopefully--priest, prophet and king, in the image of Jesus Who was all three and bestows all this Bliss upon us. You are God's workmanship: "For we are what He has made us, created us, for good works..." (Eph. 2:10). The existentialists (Sartre and Nietzsche & others) rebelled against God and basically said we, humans, are a project for ourselves, excluding God and we basically make it up as we go along. Thus, today, we see a lotta messiness, meandering



response to Hyundai and Kia's continued failure to take adequate steps to address the alarming rate of theft of their vehicles, recently joined a coalition of 18 states calling for a federal recall of certain Hyundai and Kia vehicles.

The letter, sent to the Na-Highway Traffic tional Administration Safety (NHSTA), requests NHTSA to institute a recall of unsafe Hyundai and Kia vehicles manufactured between 2011 and 2022 whose easily bypassed ignition switches and lack of engine immobilizers make them particularly vulnerable to theft. The letter calls on the federal government to step in, as the vehicles' systems are out of compliance with federal standards and pose an unreasonable risk to public safety, and the companies have failed to address these safety issues.

"Car manufacturers failing to adequately address serious said Attorney General Brown. "There is a problem with these particular Hyundai and Kia vehicles that puts lives at risk and has even resulted in multiple deaths. These companies must be held responsible for fixing the safety problem without putting the burden to do so on

the cars' owners." Between 2011 and 2022, Hyundai and Kia chose not to include anti-theft devices that were a standard feature in almost every other new car manufactured during that time period, including the same Hyundai and Kia models sold in Canada and Europe. Hyundai and Kia owners now face unnecessary risk of having their vehicles stolen, as well as related concerns, like struggling to obtain insurance for the affected vehicles.

"Even if the vehicle is stolen while the owner is safely away from their car,

General Brown. "The time lost from work, the money spent to replace their vehicle or fix damages, even the stress of trying to find alternate transportation to get to work, school, appointments, it is all a load these owners should not have to bear, nor endure."

The coalition asserts that Kia and Hyundai have not gone far enough in their attempts to remedy their vehicles' vulnerability to theft. While the companies have offered a software upgrade, this upgrade will not be available for many affected vehicles until June, and the upgrade can't be installed in some 2011-2022 models. Vehicle owners who cannot receive the software upgrade can reportedly receive a free steering wheel lock from Kia and Hyundai, but this again places additional burdens on owners and does not address the underlying ignition system flaw that makes the vehicles so vulnerable to theft. Many owners have contacted NHTSA for assistance with this theft issue.

In the letter, the states urge NHTSA to take immediate action by instituting a recall of the unsafe Hyundai and Kia vehicles because:

- The vehicles violate federal requirements that vehicles have a starting system that prevents the activation of the engine or motor and steering system when the key is removed;
- The vehicles' vulnerability to hotwiring and theft has created an unreasonable and well-documented risk to safety on U.S. roads;
- Surging thefts of unsafe vehicles have consumed law enforcement and emergency responder resources; and
- The companies' response through a phased and voluntary service campaign is insufficient to protect drivers and the public.



Sign-up period for Maryland's small acreage cover crop program now open

Program is open to small farms & urban growers who plant less than 10 acres

The Maryland Department of Agriculture announced that the sign-up period for its Small Acreage Cover Crop Program is open now through May 26. Now in its second year, the program provides grants to help small farms and urban growers plant cover crops on their production areas to build healthy soils, improve crop yields, protect local water quality, improve climate resilience and provide other environmental benefits.

"Small-scale and urban farmers play a major role in growing fresh, healthy food for local communities," said Maryland Department Agriculture Secretary Kevin A. Atticks. "The Department is excited to provide these essential growers with conservation grants that promote healthy farming practices that support local food production. I encourage all eligible growers to apply for our small farm cover crop grants

during the open enrollment sorghum, soybeans, hemp,

The Small Acreage Cover Crop Program is for urban and small-scale producers who do not qualify for traditional cover crop programs. New this year, operations that plant less than ten acres of qualifying cover crops—including cereal grains or cover crop seed mixes—can apply for grants. Financial assistance for this program is capped at \$1,500 per grower, per year.

Program highlights include:

- Maximum payment per grower is \$1,500 per year
- Growers will be reim-
- bursed based on paid receipts • Eligible species include single cereal grains or cover
- crop seed mixes • Cover crops may be planted in open plots/fields, raised beds, or a high tunnel following the harvest of a production crop (vegetables, flowers, herbs, corn,

millet, or tobacco)

• Growers should follow cover crop planting recommendations made by the seed manufacturer or the University of Maryland Extension for eligible species.

Urban and small-scale producers may download grant applications on the Maryland Department of Agriculture's website. Applications must be postmarked by May 26, for consideration in this year's program.

The Small Acreage Cover Crop Program is funded by the Chesapeake and Atlantic Coastal Bays Trust Fund and managed by the department's Small Farm and Urban Agriculture Program. 

The transition of EMS companies career staffing into county employment doesn't affect Hancock Rescue Squad yet.

The voluntary transition will begin by transferring staff from Williamsport Fire and EMS and Smithsburg EMS into county employment.

The county will also start to evaluate and determine the most economical and feasible approach to a countywide billing service.

A countywide billing service will establish uniform billing rates and billing processes throughout the county, which will also relieve the burden of billing services from the volunteer corporations.

"Williamsport Volunteer Fire and EMS is committed to furthering steps with the county taking over EMS with their plan and would like to continue talks in that direction to finalize takeover as soon as possible," said Williamsport Fire and EMS President Timothy Ammons.

Smithsburg EMS President Joan Cooper-Gerber said, "I am pleased to announce that the staffing of the Smithsburg **Emergency Medical Services** will be absorbed by the Division of Emergency Services. For several years, we have struggled to maintain the most qualified individuals in a competing market. We have concluded that DES staffing is the best solution to deliver excellent emergency medical services for our community. Our Board of Directors and staff are fully committed to this new approach and are

eager for its success." In 2007, a study on the future of EMS was conducted by a workgroup of fire and EMS officials within Washington County.

The study highlighted challenges the volunteer EMS companies endure, including issues related to staffing, financial, and administrative functions.

These challenges were carefully considered, and Washington County Government in partnership with the Washington County Volunteer Fire and Rescue Association and each volunteer fire and EMS company determined the delivery of EMS services in Washington County could not remain sustainable under the current deployment model.

It was determined the consolidation of all supplemental career staffing under the Division of Emergency Services would be necessary. Additionally, a consolidation allows both full and part-time personnel to be utilized throughout the county, enhancing both service levels and administrative efficiency.

Currently, five of the eight volunteer EMS companies have indicated an interest in moving forward with conversations to consider the transi-

tion. The transition requires the development of Memorandum of Understandings (MOU) to govern the relationship between the county and the host companies. This deployment model will help provide equity across the system with standardized competitive salaries and benefits packages.

Hancock Chief Stephen Barnhart said right now it will only be Williamsport EMS and Smithsburg EMS, but Hancock could be part of the transition "down the road."

"Washington County Government is proud to continue its collective partnership with the Washington County Volunteer Fire and Rescue Association and each of the volunteer fire and EMS comthroughout the panies County. While the County moves forward with the transition, it is important to remember that these volunteer companies will continue to depend on the donations and support of citizens," said R. David Hays, Director of Emergency Services.

Commissioner President John Barr said, "Washington County Government is committed to providing outstanding services to its citizens. As we continue to look for ways to enhance public safety services, we have full confidence that this transition will progress us in the right direc-




