

Faith resigns Hancock council seat, takes town manager position

Hancock lost a councilman on Tuesday night and gained a town manager within minutes of each other during the July town meeting in Hancock's town hall.

Michael Faith resigned his seat from the town council just a few months after being appointed to replace Misty Cubbage, who herself resigned after moving out of town

Faith's resignation on Tuesday, July 12 was accepted by the Hancock council and took effect immediately.

"I am thankful for the time I have served on the Council and look forward to your continued work to improve the town," Faith said in his resignation letter. The letter was dated July 12, 2022.

But Faith didn't leave the council table as he accepted the town manager position prior to the resignation.

Efforts toward designated School Officer in Hancock have to go through county, say officials

Town officials continued the discussion about a possible town-funded school resource officer for Hancock Elementary and Middle-Senior High School during the July town meeting. However, the probability might have knocked down, but not fully counted out.

The idea for a town funded officer at the Hancock schools came last month as Councilman Josh McCusker brought it to his fellow town officials.

The money to pay for the officer could come from the money coming into Hancock from Harvest.

"What better way to use weed money than to put it police officers," McCusker said at the time.

Fast forward a month and discussions continued with a former detective with Washington County Sheriff's Office adding to the discussion.

Retired Detective Greg Alton, who was at the meeting as part of his campaign for Washington County Sheriff, told town officials he would keep resource offi-

cers in the schools should he be elected. The primary election was held July 19, as the paper was going to print.

McCusker had asked Alton how he felt about the school resource officers, which brought him into the discussion.

Alton told town officials the conversations about the officers usually come up after a school shooting, however he added, they should always have those conversations.

He also noted the training should be always taking place, not just when there's a mass shooting.

Councilman Roland Lanehart, Jr. told Alton Hancock shares their resource officers with Clear Spring, and rarely is the officer in Hancock.

According to Alton, the Washington County Board of Education wants to expand the SRO to all schools, but the resources aren't available right now to do so.

Later in the meeting, Town Advisor Bill Valentine said he and McCusker

met with two representatives from WCPS and it didn't sound the board was enthusiastic about the town putting their own officers in the schools.

"In Washington County, the Board of Education pays for all SRO's and they don't have enough money to have any more SRO's," Valentine said.

He did say it was interesting to find out the training for officers to become and SRO is free of charge.

Valentine made the suggestion to have Hancock Police officers trained to be SRO's even though they may never be in an SRO at a Hancock school.

His point was the officers go to the school for sporting events or other activities, the county would actually pay the officer for being at the

This would help in paying the officers for their overtime as well.

Ocean City police arrest Hancock woman on theft and drug charges

A Hancock woman was arrested in Ocean City earlier this month on charges of theft and drugs after allegedly skipping out on a bill at a restaurant in the resort city.

According to Maryland Coast Dispatch, around 10:30 p.m. on July 6, Ocean City Police officers were called to a restaurant downtown for a reported theft of services.

The officer met with the server who reported he had waited on three people at a table and when he brought the bill, the patrons advised they did not like one of the menu items they were served.

The Dispatch reported a manager had taken the item off the check.

When the server returned with the modified check of around \$49, the patrons left just \$7 on the table and left the restaurant.

The officer also spoke with a manager who advised his security staff followed



the three suspects out of the bar and yelled to them if they didn't return to pay the bill, police would be called.

The manager reportedly told police the suspects walked away faster and entered a vehicle at 19th Street. Restaurant security staff was unable to locate the vehicle and its occupants, the Dispatch said.

Around 3:20 a.m. on Thursday morning, Ocean City Police located suspect vehicle at 14th Street and St. Louis Avenue and observed three suspects sleeping in-

Town advisor urges local building code enforcement to attract businesses

Citing businesses that have wanted to open shop in Hancock, Town Advisor Bill Valentine told town officials they need to look at having real code enforcement. Council and the mayor need look into buildings that are not up to code and need refurbished, Valentine said.

The discussion came about after Valentine reported on a woman who wanted to open a clothing boutique. Businesses have trouble finding acceptable buildings to occupy, he said.

Even though businesses are wanting to come to Hancock, there are a lot of empty storefronts that aren't in any condition for them to move in, he told council members last week.

Valentine requested the mayor and town council make a motion for the town to request an inspection of a list of certain buildings on Main Street.

On that list, Valentine said the buildings have "very noticeable exterior violations of the code."

That code would be the Washington County building code.

In his plan, Valentine said once the inspections are done, town officials would get a list of the violations and then send the property owner a letter drafted by the town's attorney, listing the violations and possible fines if the violations aren't repaired.

There would also be a request for the town to do a follow up inspection.

Councilman Roland Lanehart, Jr. questioned if the town could do such an inspection, prompting a re-

sponse from Town Attorney Ed Kuczynski.

Kuczynski said the town could make the request, but the owner could either allow or deny entrance for the inspection.

However, Kuczynski said if there is a denial of entrance, then the town would have to prove a reasonable cause and execute a search warrant.

Kuczynski also said the code provisions would allow for exterior inspections such as porch and decking that would be a safety hazard, gutters, or paint chipping away.

The biggest problem he said, the county doesn't have a property maintenance i nspection process. The City of Hagerstown, on the other hand, does have such a process.

The town has contracted with the county to enforce Hancock codes, which are county codes. Those codes cover the issues Valentine brought up.

If the town couldn't get the county to assist, Kuczynski said the town could independently hire someone to do the inspections and write those people up.

Those inspectors, in knowing the codes and exterior codes, could be hired to do inspections. Getting inside would be tougher to

Kuczynski said with permission it could happen, but he didn't know if people would openly give that permission.

History Matters

On July 16, 1790, the Founding Fathers ensconced the nation's capital in what History.com described as "a swampy, humid, muddy and mosquito-infested site on the Potomac River between Maryland and Virginia," named for George Washington "who saw the area's potential economic, and accessibility benefits due to the proximity of navigable rivers."

The French architect, Pierre L Enfant, was tasked with mapping out the city's layout, and George Hoban worked up the design for the White House, but George Washington would never live there because he died in 1799—a year before it was completed.

On July 22, 1862, Abraham Lincoln rounded up his cabinet and advisors to divulge his intention to issue an Emancipation Proclamation that would abolish slavery.

"Attempting to stitch together a nation mired in a bloody civil war, Abraham Lincoln made a last ditch, but carefully calculated, executive decision regarding the institution of slavery in America. At the time of the meeting with his cabinet, things were not looking good for the Union. The Confederate Army had overcome Union troops in significant battles and Britain and France were set to officially recognize the Confederacy as a separate nation," History.com reports.

Lincoln, however, waited until September 22, 1862, to release a preliminary Emancipation Proclamation, which freed all enslaved people in the rebellious states—as of January 1,

On July 30, 1619, the first legislature was assembled in

Jamestown, VA. According to History.com, "Earlier that year, the London Company, which had established the Jamestown settlement 12 years before, directed Virginia Governor Sir George Yeardley to summon a 'General Assembly' elected by the settlers, with every free adult male voting. Twenty-two representatives from the 11 Jamestown boroughs were chosen, and Master John Pory was appointed the assembly's speaker. On July 30, the House of Burgesses (an English word for "citizens") convened for the first time. Its first law, which, like all its laws, would have to be approved by the London Company, required tobacco to be sold for at least three shillings per pound. Other laws passed during its first six-day session included prohibitions against gambling, drunkenness and idleness, and a measure that made Sabbath observance

Dear EarthTalk:

Are oil companies actually taking steps to cut emissions overall or are their claims mostly just "greenwashing"?

—J.B.S., Waukesha, WI

It's no secret that the climate crisis is intensifying and the world is looking for solutions. The Intergovernmental Panel on Climate Change (IPCC) stated in its latest report that we are facing a "code red" for humanity if we are unable to make substantive changes. According to the IPCC we must cut our carbon dioxide (CO2) emissions in half by 2030 in order to secure a livable future. Even though there has been a push for emissions reduction, global emissions are not showing signs of declining.

As top contributors of pollution, oil companies are under a microscope. In response to increased pressure, many have begun to make promises that they are working towards being part of the solution. The scientific journal PLOS One reports that major oil companies are using terms like "climate," "lowcarbon" and "transition" more frequently in their reports and claim that they are striving to go "carbon neutral."

Carbon neutral is as much of an oxymoron as there can be when applied to oil companies, which begs the question: How do they plan to accomplish this goal? One way they are trying to achieve net-zero emissions is by investing in nature-based carbon credits. Essentially, they are pledging money to plant trees that absorb the CO2 equivalent of the output of their

While this solution seems simple enough, common criticisms of oil companies' responses are that net-zero promises are solely based on facility operations and not on the fuel sales themselves; additionally, oil companies have continued to invest in more acreage for the express purpose of extracting more oil—thereby showing their true priorities. Researchers at Tohoku University and Kyoto University conclude that transitioning to clean energy is not occurring because investments and actions by oil companies simply do not match the public promises they are making.


It's important to understand that nature-based credits come with complications. It takes years for trees to mature so it's often unclear how much CO2 they'll absorb. In addition, the lifespan of these trees is not a guarantee either: With increasingly warm and dry conditions, there is an increased likelihood that these trees could die due to drought or fire, in which case the carbon offset becomes worthless.

So, are oil companies simply greenwashing? Some have made minor efforts but it is not nearly enough. That being said, it is important to know how we as individuals can still make a difference. Divesting from oil companies will help reduce the amount of money going towards these polluters. Even if you are not giving money directly to oil companies, your money can indirectly exacerbate the problem. Doing your due diligence to make sure that your bank is not funding oil companies along with other investments in your portfolio can make a world of difference. Reallocating money to make sure you are investing in a clean energy future will help to take the fate of our planet out of the hands of big oil compa-

The vehicle make, model, and tag number matched the vehicle seen leaving the area where the alleged theft of service occurred the night before, the Dispatch said.

The female front seat passenger was identified as Joshalvn Morris, 22, of Hancock. The vehicle was determined to be unregistered and uninsured and tow truck was called.

Morris told Ocean City Police she left \$8 for her part of the \$9 restaurant bill, but only a total of \$7 was left at the table before the suspects fled the scene.


The Dispatch said Morris then reportedly told police she wasn't going to pay the bill until the item the party wasn't happy with was taken off the check.

Morris was arrested and charged with theft possession of heroin and fentanyl and possession of paraphernalia. According to online court documents, Morris was also charged with having a concealed dangerous weapon.

Morris was released on \$2,000 bond.

A trial date has been set for October 7 in Worcester District Court.







Pa. governor signs order to keep reproductive care access open

Pennsylvania Governor Tom Wolf signed Executive Order 2022-01 on July 12, aimed at ensuring out-of-state residents may enter Pennsylvania to access reproductive health care services in the commonwealth.

"The executive order also affirms the governor shall, while still adhering to state law and the US Constitution, decline any request received from any other state to issue a warrant for the arrest or surrender of any person charged with a criminal violation involving the provision, receipt of, or assistance with reproductive health care services unless the basis of the criminal charges are also criminal offenses under Pennsylvania law," said Wolf's office.

"The Supreme Court's decision to dismantle Roe v. Wade has invoked fear and uncertainty across our nation but especially in states where access to reproductive health care services is being questioned and, in some cases, banned," said Gov. Wolf. "By signing this executive order, I am affirming that individuals seeking and providing reproductive health



services are safe in the commonwealth from discipline and prosecution. Everyone, whether a resident of Pennsylvania or elsewhere, deserves access to health care. As long as I am governor, I will do everything in my power to protect that right."

Keefer completes Academy for Excellence in Local Governance

Washington County Commissioner Wayne Keefer recently completed coursework for Maryland lawmakers and government officials called the Academy for Excellence. Keefer, of Hancock, will become a Fellow of the Academy For Excellence in Local Governance.

The Academy For Excellence in Local Governance voluntary certificate program is collaborative effort involving Maryland Association of Counties, Maryland Municipal League, The Local Government Insurance Trail, and the School of Public Policy of the University of Maryland, College Park.

The Academy is an educational resource for the professional education needs of Maryland local government officials, "providing the tool to make educated decisions on highly complex issues and to meet the challenges of their role, as well as to promote high ethical standards expected of elected officials," according to the program description.

County government officials enrolled in the program are required to take eight "core" classes and six "elective" classes.

In order to be graduation eligible and to receive academy certification, Keefer took core classes Basic Risk Management, Conducting Effective Meetings, Consensus and Team Building, County Financial Manage-



ment, Employment Issues, Ethics, Open Meetings, and Public Information Act.

For elective classes, Keefer participated in Second Chance Workplace Success: A Good Program is Good For Your County, Angling for Educational Excellence, Handle with Care: Substance Exposed Newborns, Tech Expo Deep Dive, Beyond Classifieds: Finding and Keeping the Employees You Need, and Delicious or Deadly? A Food Safety Update.

Keefer said he was honored to have graduated from a respected program in Maryland and nothing is more important to an elected official than understanding the issues facing their constituents and finding resolutions.

"This academy has helped me to become more knowledgeable of many ways I can assist those I serve every day in Washington County,' Keefer said.

He fills a position that has been vacant for just over 13 months. Former Town Manager Joe Gilbert was fired during the June 8, 2021 town meeting. Consultant Bill Valentine has been acting as the town's advisor while officials decided how they wanted to replace Gilbert.

If the town were to do any kind of grant program, a condition of that is going to be an inspection to know what would be needed to bring the building up to minimum standards, Kuczynski added.

Town officials did not make any decisions or movement on the future of any code enforcement.

Valentine requested officials contact the county to come in and do the inspections.

Kuczynski did say he, along with town officials, would have to go back and look at the building codes and itemize what can be violations can be considered infractions.



Regulations for being an SRO are vastly different than being a regular police officer, Valentine added.

There are things inside the school system that are criminal activity, which would be handled by police, but others are just policy violations and would be handled differently and not as a police officer.

Valentine said he thinks the Hancock officers should be trained in case something happens at the schools and the SRO is a half hour away.

It was also explained to McCusker that once the Hancock officers are trained as SRO's, the town could enter into an MOU with the Board of Education similar to what Hagerstown has with the

Washington County Sheriff's Office have.

Under that agreement, Mc-Cusker said if WCPS can't get staffing for a sporting event, they can go to the Police Department and ask if they have any officers available.

McCusker said the Hagerstown Police who are SRO's are also funded by WCPS.

"They're definitely open to getting more officers, they want that, it's just a matter of funding," McCusker said.

The 2023 fiscal year budget for WCPS went into effect on July 1, so the funding isn't available. McCusker said there are probably more meetings on the subject in the future.






