Special meeting, workshop Thursday evening

Town officials will be holding a special town meeting followed by a tomorrow workshop evening, July 28, at 6 p.m. in the Hancock Town Hall and Community Center.

The special meeting will be to vote on appointing a new councilperson to fill the seat vacated by Mike Faith after he resigned to take the job as town manager. There will also be a discussion about an Emergency Public Works replacement purchase during the meeting.

Both meetings are open to the public. During the workshop, however, town officials cannot make decisions or vote on issues. While it is a public meeting, there is no citizen comment period.



Storm leaves damage, few with no power

Residents in Hancock were rocked by a quick moving, powerful storm that uprooted trees, knocked out windows, and knocked out power to a number of folks Saturday evening.

The storm came through around 5:30 p.m. Saturday, July 23 with driving rain, hail, lightning, thunder, and strong winds.

Pictures on social media showed trees and debris along the Western Maryland Rail Trail and store windows blown out.

Electricity was knocked out for some residents, with Potomac Edison reporting 29 Hancock residents without power. There are 2,174 customers in Washington Hancock. County overall had 694 out

of 53,688 customers without power, according to Potomac Edison's website.

Power had been restored around Hancock by Monday evening.

According to the First Energy website, power was knocked out due to tree and equipment damage. Sunday morning, crews were repairing a pole along Main Street that had been damaged in the storm.

"Crews are working as quickly and safely as possible to restore service to about 7,600 customers without power due to yesterday evening's storms, down from about 22,000 total customers impacted. As the storms moved through our service area, severe weather caused significant tree damage, downed poles and power lines, with the hardest hit areas located in Washington County, Md., Morgan County, W.Va, and Hampshire County, W.Va," Potomac Edison said in a statement on their Facebook page.

New BA.5 variant causing most COVID cases now, including reinfections



Most new COVID-19 cases nationwide are tied to the newest BA.5 variant of the virus, according to CDC officials.

Washington County reported 55 new cases of COVID on Friday, July 22.

The BA dominant strain of COVID-19 is what public health workers are calling "highly transmissible" and just different enough from other viral strains that it can slip past immunity from vaccination and previous infections.

In other words, the BA.5 variant is getting around quickly, and can reinfect people who are fully vaccinated, with a vaccine booster and with natural antibodies from a prior case of COVID. Those with antibodies are reporting having a milder case of illness than



those who encountered earlier strains before vaccines were available.

Public health workers don't believe this variant causes more severe respiratory illness that other versions of the virus.

Doctors have said most people in America by now have some "underlying immunity" that helps them fight the virus, either from a vaccine or earlier illness.

Pennland Pure wins American Cheese Society Awards

Pennland Pure of Hancock recently won three awards for its cheeses, the American Cheese Society announced at its annual conference in Portland, Oregon Wednesday, July 20.

About 200 companies from across North and South America entered 1,387 cheese products in 120 categories for the competition. Judges at the University of Minnesota determined the winners based on flavor, aroma, texture and appearance.

Pennland Pure Sharpsburg Cheddar won second place in the aged cheddar category. These cheddars are aged from 13 to 23 months.

Pennland Pure Provolone also won second place in the pasta filata category. These types of cheeses, like provolone and caciocavallo, are cooked and stretched.

Incumbents Cline, Wagner & Keefer are top vote-getters in primary for commission

Washington County Board of Commissioners President Jeffery Cline was the apparent top vote-getter in the crowded commission race in last Tuesday's primary election. Cline, Randall Wagner and Wayne Keefer -- all incumbent commissioners -emerged as the top three candidates on the GOP ballot for county voters. John Barr and Derek Harvey rounded out the top five candidates in the Republican primary race, which included a total of 15 candidates.

Preliminary vote totals from the Washington County Board of Elections reported the following:

Jeff Cline - 5821 Randall Wagner - 5540 Wayne Keefer -5407 John Barr – 5316 Derek Harvey - 5083

Democrats Sterling Sanders and Dave Williams were the two candidates on the Democrats' ballot for that party's voters looking to fill five seats on the Board of Commissioners. Sanders pulled in 2995 votes while Williams received 3040.

In November, Washington County voters will narrow the field to the five commission-

Sheriff's race

Republican Jim Holsinger was the front-runner in the GOP primary for Washington County Sheriff, receiving 4162 votes. Democrat Junior McLeod, with no opposition on his party's primary ballot, pulled in 3132 votes. Holsinger and McLeod will face off in November's general election.

Questions & Answers About Our Environment

Dear EarthTalk:

How are reptiles faring these days in the face of climate change and other environmental threats?

-L.M. Smith, Boston, MA

Reptiles, like other animals and plants, face growing threats as human influence on the environment increases. Certain reptiles are especially threatened; some 61 percent of turtles are threatened or extinct. Tracking the exact consequences of human activity on reptiles, however, has been difficult as research has primarily focused on mammals and birds, which draw more public attention, although evaluations have found reptiles to be more threatened than birds.

A recent study that observed 10,196 species determined that 21.1 percent of reptiles are at risk of extinction. These species contain an estimated 15.6 billion years of phylogenetic diversity (PD). This science uses a phylogenetic tree, which shows how closely related species are, to describe the amount of biodiversity in an ecosystem and obtain a more useful measurement than just counting numbers of species. In addition, the adaptations of reptiles to ecological conditions perform help sustain ecosystems, including supporting food chains. Threats to reptiles include habitat loss and environmental damage, invasive species, diseases, pollution, exploitation, poaching and global climate change.

Habitat destruction is the largest threat. As urban sprawl, overgrazing and desertification—which in turn prompt expansion of logging and agricultural operations—put greater pressures on land, reptile habitats have been overtaken by humans, creating increasingly stressful conditions for reptiles. Shrinking habitats increase edge effects—which are the effects of separating habitats (like with a road) such that animals cannot reach resources or mates in other parts of the habitat. Now climate change is exacerbating these pressures. Since many reptiles are ectothermic—they cannot generate internal heat and instead rely on external conditions (e.g. sunlight) to warm themselves-temperature increases due to climate change affect them significantly. Many arid-climate reptiles (e.g. lizards and geckos) are already experiencing extremely high temperatures, and minor increases could make their already limited habitats unlivable.

Furthermore, reptiles are particularly prevalent in regions of Southeast Asia, where disruptions to monsoon cycles can obstruct development of reptiles in embryo. Many species turtles, crocodiles and alligators, for example—lay eggs in wet conditions. Newly-dry and disrupted regions threaten their abilities to survive, cause slow development or growth and skew the natural selection of sex ratios.

Some good news is that methods implemented to protect other types of animals—reducing tropical deforestation, controlling illegal trade and improving productivity in agriculture such that agricultural lands do not need to be expanded—benefit reptiles similarly. However, the current crisis behooves more action to improve conditions for reptiles in particular.

Readers should encourage their representatives to take action. Reptiles play a crucial role in the Earth's ecosystems, and concerted solutions have the potential to make all the dif-





Cases of local vandalism call town security cameras into question

Vandalism of picnic tables and Civil War kiosks have caught the ire of former Mayor Dan Murphy, raising concern about the town's security cameras around town.

Murphy spoke during citizens' comments at the July meeting about the town's museum from the second floor of Town Hall back to the basement before he put on his Rotary hat and told town officials about a picnic table in Widmeyer Park.

Rotary had recently donated handicapped accessible picnic tables at all the Hancock parks as one of their projects.

Murphy said he was made aware of a table that had been 'severely vandalized" in the Lions Pavilion.

After checking out the picnic table, Murphy said the town's Public Works crew had already "made a world of difference" in bringing the table back.

Murphy's leading question, he said, would be, "Who did

"My point is, you should be able to tell me because there should be cameras in that area," Murphy said.

There are town cameras in Widmeyer Park near the Lions Pavilion, which should give the police an idea who

A few months prior, Murphy also asked town officials and police who vandalized the kiosks in the Civil War Heritage Park on Main Street as there are cameras there as

Police said someone had broken one of the kiosks.

Murphy said he was told the cameras were not pointed in the direction of the kiosks at the time the vandalism

"My question is, 'Do we

have cameras that are working and if not, why?" Murphy

He pointed out the cameras the town had placed in various spots around town, which were placed under his administration, had been a deterrent to crime in town.

"It's been proven," he said. Murphy admitted the company the town used for the cameras was "no good" and had stagnated.

"We put an end to vandalism because people knew they were on camera," Murphy said. "Now they're going to know what they can get away with."

Mayor Tim Smith said the bandstand in Widmeyer Park was also vandalized, noting kids will be kids and use pen, but this had been done with paint.

The bandstand had been donated to the town as well.

Smith also asked about pulling the cameras at the pavilion in the park, however they were not working as well.

"Why aren't the damn cameras working when we need them?" Smith asked bluntly.

Smith said families are renting these pavilions and bandstand all the time and shouldn't see some of the things written on them.

"I don't want to be blunt about this, but it has to be something because I'm not going to tolerate these, what I call hoodlums, destroying everything," Smith said.

He added if the cameras aren't working, it tells him the company the town has isn't doing their job.

"Is there no monitoring system to know when these cameras are working, when they're not working?" Smith

He wants all the town cam-

eras to be working and knows there have been requests to add more cameras to Town

"If we put the cameras in, is it going to do us any good if they're not working?" Smith asked.

Murphy told town officials how good the cameras were at one time, telling the story of how then-Police Chief T.J. Buskirk caught two people drinking beer in the park and was able to tell them the brand they were drinking because he could read the cans just by zooming in on the image.

He also told of Buskirk catching vandals in Joseph Hancock Park and was able to meet them at home as they got off the school bus and took care of the problem right then.

"It can be done, I've seen it happen," Murphy said. "When you have minimal number of people on your police force, you need all the eyes you can use."

Murphy said they still don't know who damaged the kiosks in the Civil War Heritage Park and it's been at least two months.

Smith agreed, saying it's every week there's cleaning done in the Widmeyer Park bathrooms and no more than an hour later, the soap dispensers are ripped off the wall and toilet paper dispenser off the wall.

"I know that people say our kids don't have anything to do, but I can find something better to do than ripping the toilet paper holder off the wall or soap dispenser," Smith said.

Murphy encouraged the town to get the new town manager, Mike Faith, and the police department to get the cameras working as it's a big part of their role.

"At some point, it gets to be there's no excuse not to know who damaged that picnic table out there," Murphy

Sgt. Rich Miller of the Hancock Police told The Hancock News on Monday that out of 13 cameras, only one is down right now. Miller did not disclose where that camera is located.

He said the power company had noticed the camera was not hooked up correctly when they were doing upgrades for Harvest.

The vendor for the cameras has not been able to repair that camera and the police and town are currently working with the vendor to get that camera back up and running.

Miller said he has addressed issues with town officials and they are currently investigating new cameras with better upgrades.

As for vandalism, Miller doesn't think there has been a rise and it's been about the same as before.

The cameras in town did help with solving a vandalism case this past holiday season.

One of the parking meters in town had been decorated with bells and someone decided to mess with the bells.

Miller said because of the cameras, the person who caused the vandalism was caught.

This helped many, thousands of people!...After contemplating this and with help of the Archdiocese and others' recommendations, and counsel, we are shifting - as we will be handing out

free groceries, holy water and food, and essentials-coupons, instead of greenbacks ...

In the famous passage of Jesus 's disguised-return, as a beggar (Mt. 25: 35) & as an in-jail person, etc. He does not ask to be sent to the government or an agency or some counselor, but desires direct action and attention. So hopefully our new way of doing things is both personal and prudential—like making a "square circle"!...

Actually a Saint in India counseled actually a Saint in India counseled us just this Way . Notice in the famous distressing disguise passage (Mt. 25) that Jesus doesn't want to be sent around here and there or be served third or fourth hand-like, but rather, intimately...

In famous stories like Saint Martin of Tours (feeding a beggar Who turns out to be Christ) and Saint Catherine of Siena (kissing a leper) along with Saint Francis of Assisi (living with the poor) we witness traumatic stories of direct and visceral service to the poor... We Catholics and Bible believers should continue this and I invite and encourage you to contemplate to continue, if you are writing a check, or sending aid overseas, or praying and fasting for the poor, to also consider direct action for them...

This may include visiting a nursing home or serving at a soup kitchen or like place or a helping a neighbor in need or others where we encounter directly the poor and the sick and the needy, Jesus in His distressing disguises... Last week, while on the streets handing out food, a lady thankfully waved her hands in the air in praise of God and said that these gifts were sent and spontaneously embraced us and began tearing up. This inspired me in this direct action as that day I was kind of tired and weary and blurry about my mission, and she reminded me of the need never to cease doing good and that direct action toward the distressing disguises Jesus is Ultimate... In the city and elsewhere, as I've learned, we need to be careful and charitable... It is good and even necessary to have programs of service and it is also good to serve people who are not only fundraising pictures or mere numbers or plastic biographies we read about, but rather real persons with desires and needs...

Our main mission in life is to save and sanctify souls-- especially if they are needy and thirsty and hungry...Do you thirst for this?!

Maryland hunters can now enter 2022 black bear hunt lottery

The Maryland Department of Natural Resources (DNR) is now accepting applications for the 2022 black bear hunt lottery.

Successful applicants will receive a permit valid for the 6-day hunting season, which for the first time includes a Saturday. The hunt will be open October 24-29 in Allegany, Frederick, Garrett and Washington counties.

"The annual bear hunt, now in its 19th year, is an important management tool used to slow the increase of Maryland's black bear population and limit expansion of Maryland bears into the eastern suburbs and cities," said DNR officials.

The department will once again issue 950 hunting permits this year.

"Maryland's science-based bear hunt remains well-reguand sustainable,"

Hunters may apply for the lottery online or at one of more than 250 hunting and fishing license agents across the state. Hunters need a valid DNR ID number to partici-

All entries must be completed by 11:59 p.m. Aug. 31 and must be accompanied by a nonrefundable application fee. Only one application per person will be accepted; submitting duplicates can result in disqualification and forfeiture. The drawing will be held September 7, and win-

ners will be notified shortly thereafter.

When applying for a permit, hunters can make voluntary contributions to the Black Bear Damage Reimbursement Fund, which directly reimburses Maryland farmers who have suffered agricultural damage caused by black bears.

The fund has paid farmers more than \$130,000 since its establishment in 1996.

Primary results -

Washington County voters cast ballots during early voting, through absentee ballots and at polls on Tuesday, July 19. In total, 15,751 ballots were cast from a roll of 74,665 eligible voters in the county. That's a 21% voter turnout.

Voters made their party primary picks for offices from the top of the state down to county level posts.

Wash Co went for Cox

Washington County voters went heavily for Dan Cox for the GOP candidate for governor, as did the rest of Maryland Republicans. Cox and Gordana Schifanelli pulled in 59.8% of the county vote in that race. Statewide, Cox earned 133,068 votes - 56% of the GOP ballots.

Democrat Peter Franchot was favored by Washington County Democrats on the gubernatorial ballot, pulling in 27% of this county's votes in that race. Franchot got just 19.6% of votes across Maryland. Instead, Maryland Democrats tapped Wes Moore and Aruna Miller as their picks to be on the November ballot. Moore took 36.7% of the vote across the state.

On the Congressional ballot representing District 6 in the U.S. House of Representatives, Republican Neil Parrott topped a list of six GOP candidates, earning 26,866 votes in early and electionday voting. Democrat David Trone is his party's pick for the November ballot, pulling in 23,534 votes over two challenges in the primary.

U.S. Senator Chris Van Hollen won the Democratic primary in a race to keep his seat. Republican Lorie Friend won the GOP primary and will face Van Hollen in November.

Delegate & State Senate race

Mike McKay was Washington County's pick for a GOP candidate for State Senator representing District 1. McKay, currently a delegate, received 2343 votes in Washington County while his chal-

lenger Jake Shade got 1252. Districtwide, McKay pulled in 7,996 votes to Shade's 6,359.

Democrat Michael Dreisbach was unopposed on his primary ballot and pulled in 708 votes in the State Senate race here in Washington County. Districtwide, Dreisbach got 2,596 votes.

Terry Baker's run for Maryland House of Delegates to represent District 1-C garnered the commissioner 2,906 votes on the GOP ballot in Washington County. Districtwide, Baker got 3474 votes. Baker decided not to seek re-election to the Washington County Board of Commissioners in order to make the state run for Mike McKay's seat.

Democratic candidate for the House of Delegates seat, Carrie Hinton, received 700 votes in Washington County and 777 in the district as a whole. Baker and Hinton will face off on the November ballot.

At the county level, Robert Breeding won the GOP primary for Treasurer. He has no Democratic opponent in November.


Gina Cirincion was unopposed in her GOP primary race for State's Attorney, and has no Democratic opponent in November.

Kevin Tucker cleared his primary for Clerk of the Circuit Court with no GOP opponents or Democratic challenge.

Republican Lacy Flook will face Democrat Jason Malott in the Register of Wills race in November.

Three Republican candidates will be on the ballot for Judge of the Orphan's Court in November – Paul Banister, Debra Breeding and Anthony Lowman.







Reward offered for information leading to arrest of suspect in fatal hit-and-run

Maryland State Police are asking for the public's assistance in identifying a suspect in a fatal hit-and-run work zone crash that occurred last month in Washington County.

At about 4:19 a.m. on June 19, troopers from the Maryland State Police Hagerstown Barrack responded to eastbound Interstate 70 west of Maryland Route 66 for a report of a pedestrian who was struck while working in a construction zone. According to a preliminary investigation, a road crew was backing up in the left lane of eastbound I-70 and removing construction barrels from a previous roadway project.

The victim, Ever Anibal Aleman Ramos, 34, of Capitol Heights, was pulling barrels from the roadway behind a crash attenuator truck when he was struck. According to a preliminary investigation, the

driver of the striking vehicle pulled onto the right shoulder for a short time, but soon left the scene. Ramos was declared deceased at the scene.

The suspect vehicle is described as a gray or silver, older model pickup truck, possibly a Ford Ranger or Toyota Tacoma. Ramos' employer is offering a \$10,000 reward for information leading to the identity and convic-

tion of the hit-and-run driver.

The Maryland State Police Crash Team is investigating this case. Anyone with information as to the striking vehicle or other information regarding the crash is asked to contact the Maryland State Police Hagerstown Barrack at 301-766-3800.

The crash remains under investigation.
