

Council discusses ways to permit food trucks, temporary stands under existing mobile home ordinance

Hancock town officials are weighing their options to change or fully enforce a town ordinance regarding mobile homes and vehicles within their town limits. A special town meeting on the subject was held this Monday, August 15.

Councilman Roland Lanehart, Jr. said he talked to a number of residence and businesses and came up with a couple ideas on how to improve the ordinance, which restricts where and how mobile units can be located.

His first proposal was that any business owner paying property tax and utilities should be able to use a shed

or trailer as long as they own that shed or trailer and are paying taxes on the property.

In the case of food trucks, pop up shops, or food trailers, those business operators would also need to get a permit from the town for no more than three consecutive days and be moved after those three days, he pro-

In the event of a holiday weekend, such as Memorial Day Weekend, Lanehart said the permit would be extended to a fourth day.

Vendor permits run \$50 a day, he added.

Ed Town Attorney Kuczynski said it would be



hard to enforce this. He said someone could have their permit pulled if they don't pay their taxes or bills.

Town Manager Mike Faith noted Lanehart's ideas would mean the owner would be in good standing.

Hancock splash pad still under development

Town officials are still looking at the possibility of getting a splash pad made before diving in to build a new municipal pool.

The question was raised during the August town meeting last Tuesday evening, August 9, by April Davis during citizen's comments and later addressed by Councilman David Kerns.

When Davis came before officials, she asked officials if there was anything new regarding the pool.

Mayor Tim Smith said a representative from Fox and Associates is going to be meeting with himself and Town Manager Mike Faith. The pool would be the



same size as originally decided on a few years ago.

Plans for the pool would have to be re-submitted to the state for approval, said

It's unknown until plans are finalized what the price would be for that new pool.

Smith has reached out to the original contractor if they would want to rebid the proj-

Vehicles were lined up around Widmeyer Memorial Park and down to Save a Lot last Saturday, August 13 for the ninth annual Hancock's Helping Hands event organized by the greater Hancock council of churches.

The drive-thru opened at 10 a.m. and the last vehicle pulled out at about 12:20 p.m. with the final two backpacks, according to event organ-

"This is our third year doing the drive-thru. We did two lanes. It's much more efficient for everybody. We don't have to set up tents around the park, and its more convenient for those with disabilities," said event organizer Kristie Stotler.

Everyone gets something, not just school-age kids, according to Stotler. Pre-K to high school students got a backpack, underwear or personal care items. Expectant moms, babies and toddlers got baby care bags. Every adult got a meal, socks, and

personal care items. Each household also received items not covered by EBT food cards, including laundry detergent, dish detergent, toilet paper, tissues and paper towels. Snow cones were offered to all on their way out.

"There is definitely a greater need this year, as we served almost 200 more people than last year. It truly is a blessing to be able to touch the lives of so many people," said

Volunteers from Orchard Ridge First Church of God, Hancock Presbyterian, and St. Thomas Episcopal were on hand to direct traffic, greet people, and fill orders until the line disappeared.

"We like helping the community. Folks have been having a tough time," said Pastor Jeff Hawbaker with Orchard Ridge First Church of God, as he greeted people, offering them a Bible and words of encouragement as they made their way to the drive-thru.

CDC changes COVID-19 guidance on quarantine and social distancing

The Centers for Disease Control and Prevention issued new COVID-19 guidance on quarantining and social distancing last Thursday. They recommended that if a person was not upto-date on their COVID-19 vaccines and was exposed to the virus, that instead of quarantining they should wear a high-quality mask for 10 days and get tested for COVID on Day five.

Staying six feet away from others was also dropped from their recommendations. Physical distancing was listed as one mode of protection where individuals would consider the risk in specific settings, the Community COVID transmission levels and ventilation to assess the need for maintaining physical dis-

Testing asymptomatic individuals without known exposures would no longer be recommended in communities. Masks are still encouraged in communities where transmission levels are high or in individuals whose immune systems are weakened or who are at risk of severe illness from COVID.

CDC stance

CDC officials said in their press release that the United States is in a stronger place to protect people and communities from severe illness from COVID. The country has more tools to fight COVID including vaccinations, boosters, high-quality masks, testing, medical treatments and better ventilation than earlier in the pandemic. There is now less risk of severe illness, hospitalization and death from the disease, according to the


While some officials praised the CDC's steps to update their recommendations, others had concerns especially with COVID increasing in some communities and the opening of school being right around the corner.

CDC guidelines

Stay up to date with COVID-19 vaccinations to protect yourself against serious illness, hospitalization and death, especially as protection against new variants wanes and new vaccines become available.

Regardless of vaccination status, the CDC advises isolating from others when you have COVID. Also isolate if you're sick and suspect you have COVID-19 but don't have the test results yet. If you are negative, you can end your isolation.

If your COVID test results are positive, you should stay home for at least five days and isolate yourself from others in your home. Wear a high-quality mask when you must be around others in your home and in public. If results are negative, you can stop your isolation. The FDA now recommends three repeated at-home rapid



antigen tests to determine negative results.

If after five days you are fever-free for 24 hours without the use of medication and your symptoms are improving or you've never had symptoms, you may end isolation after Day five. Avoid being around people who are likely to get very sick from COVID until at least Day 11. Wear a high-quality mask through Day 10.

If you had moderate to severe illness from COVID, you should isolate through Day 10. That includes shortness of breath or difficulty breathing or being hospitalized. If you had severe illness or have a weakened immune system, see your physician before ending isolation. A COVID test may be necessary first.

If your symptoms recur or worsen after your isolation is over, begin your isolation again at day zero.

The CDC will continue to focus on preventing severe illness and post-COVID conditions and providing the information and tools for all to lower their risk from COVID, officials said.

Questions & Answers About Our Environment

Dear EarthTalk:

I know that upgrading the energy efficiency of my home will make it less expensive to heat or cool, but will it also raise its market value significantly?

- J.B.M., St. Louis, MO That depends on your definition of "significant!" According to a study published in the Journal of Urban Economics, with every 10 per cent increase in energy efficiency, a home's market value increases by approximately 2.2 per cent. In another set of studies, the government-backed energy efficiency experts at Energy Star found that their certified homes in Maryland sold between 2012 to 2015 had a two to five per cent sales price increase, simply because they were deemed energy

This pattern has been observed across the U.S. A six percent increase was seen in the final price tags of Energy Star certified homes in Austin-Round Rock, Texas (sold 2009 to 2016), and an eight percent increase was found in select housing markets across Oregon, Idaho and Washington (2015).

Why is this happening? To put it simply, the average home buyer has become savvier in the world of sustainability. In a report by the National Association of Realtors (NAR), it was found that 51 percent of agents interacted with clients that were very interested, or at least somewhat interested, in sustainability. In a related report by Energy Star, the stats showed that 83% of home buyers desired more efficient windows, 81% wanted more efficient appliances, and 80% wanted more

Undoubtedly, homeowners have come to understand that energy-efficient upgrades translate into lower energy costs. According to the U.S. Department of Energy, the average family spends approximately \$2,200 annually on energy bills. Thirty percent of that cost can be removed just like that through energy-efficient home modifications.

That being said, the increase in demand for sustainable homes and home upgrades may also be driven by a sense of personal responsibility. A sweeping study by Simon-Kucher & Partners covering 17 countries and 10,000 participants revealed that a significant paradigm shift in purchasing habits was occurring. Eighty-five percent of respondents reported that they had changed their spending habits over the past five years to accommodate a greener lifestyle. In addition, onethird of the population is willing to spend more for sustainable products or services—as much as 25%!

If you're feeling the same inclination, there are many ways to upgrade your home's energy efficiency. Insulating walls is usually where people begin, but sealing air leaks (even the small ones!) with caulking, spray foam and weather stripping can save anywhere from five to 30% on energy. Ducts specifically are known to have leaks that can cause losses of as much as 60% of the heated air traveling through them. Energy efficient light fixtures, windows, doors, skylights, appliances and hot-water heaters are all available for purchase these days, and when used in congruence with a programmable thermostats and smart-device timers, you can save a surprising amount of money in energy savings by the end of the year.

Citizen takes issue with local rumors, downtown business during Hancock council meeting

The citizen comment period of the August 9 meeting included issues aired by a downtown property owner about her business and interactions with local people and officials.

Rachael Truitt came to the August town meeting to address a few issues she had that involved the police and the wife of the mayor.

Before the start of that particular part of the meeting, Mayor Tim Smith told everyone the parameters of citizen's comments, which he had not done in previous meetings under his adminis-

The agenda for the meeting, which is available at the back of the room at each meeting, states each person would be "limited to 5 minutes per individual" and the mayor reserves the right to reduce the time "if deemed necessary" to conduct town business.

Truitt addressed town officials by starting with the 'hateful slander" directed toward her, her husband, and his business.

She said her husband was wrongfully accused of stealing a vehicle, and police agencies from Morgan County and Hancock came to them with accusations of grand theft auto.

When provided legal documentation of the vehicle own-

ership, police realized there was no wrongdoing.

"To this day, the vehicle is still in our possession, as it should be, and is licensed, tagged, and registered legally through the state of Maryland," Truitt said.

The couple allowed the person who made the complaint to get their belongings from the vehicle and offered to have police with body cams oversee the collection.

People should hear both sides of a story before they run with one side, she added.

A second incident involving a job done on a vehicle was dismissed in court by a judge.

Truitt's husband recently purchased the former Douglas body shop building and property across the street from Steve Douglas.

The process took 77 days for completion, Truitt said.

Truitt said she had heard negative things about the food truck on one of the lots, including that it was rarely

"As business owners, we do not go, and won't go, on he-said-she-said," she said. "We conduct our business affairs on facts."

Over those 77 days, Truitt said they watched and saw the food truck open, and the owner kept the area clean and seemed "very nice," which is why the Truitts wanted the owner to stay.

Truitt alleged the food truck's main critic was Linda Smith, the wife of the mayor.

Truitt claimed the dispute between the food truck and Smith was over personal mat-

After meeting with the food truck business, Truitt told her she wanted the business to stay.

It was also at this time Truitt said they were made known of the town's ordinance regarding mobile homes and vehicles. Truitt said she wanted to help the owner work out the problem.

"We had no intention of making her leave," she said. 'The only thing we asked her was for her to move the trailer sideways as we would be needing this parking lot for other things as well.

An ordinance about mobile homes and travel trailers was brought to Truitt's attention, she said, but their RV had already been in town for four years at that point.

Five minutes into Truitt's remarks, Mayor Smith cut her comments off, noting her five minutes of time was up.

This was the first instance where Smith has called time on citizen comments during

his term as mayor. Truitt asked if her husband could also get his five minutes of public comment, but

Smith denied that request.

When Truitt stated she was getting to the part that was about town business, namely the ordinance discussion, Smith said he would not allow her any further time.

"Are you afraid? Are you afraid of the facts that are about to be presented?" she asked the mayor.

Smith again told Truitt her five minutes were up and to take her seat.

Truitt left the meeting room to have a conversation with another audience member in the hallway but did not return to the room.

A special town public meeting about the mobile home ordinance in the Town of Hancock was held on Monday, August 15.

Gaming Commission awards over \$2.5 million in allocations

The Washington County Gaming Commission announced its gaming fund distribution to the Washington County Volunteer Fire and Rescue Association, as well as 66 local charitable organi-

The Gaming Fund total of 2022, which ended June 30, represents an increase of \$129,336.68 when compared to fiscal year 2021 revenues.

State law requires funds be divided equally between the Washington County Fire and Rescue Association and local charities, and in January the Washington County Fire and Rescue Association received \$565,192.92. As of today, an additional \$730,313.55 will be distributed, bringing the yearly total for Fire and Rescue to \$1,295,506.47.

In May, the Washington County Gaming Commission received 84 separate applica-

tions from 75 charitable organizations requesting a total of \$2,062,148.54. After a gaming hearing in June, and one-day workshop in July, the Commission was able to either partially or fully fund 66 of the 84 requests. Of the 84 applications received, 44 \$2,591,012.93 for fiscal year received full funding, 22 received partial funding, and 18 were denied funding. A total of \$1,295,506.46 of 2022 gaming funds were allocated to 60 of the 75 charitable organizations applying.

The Community Free Clinic received the largest award of \$175,000 followed by R.E.A.C.H of Washington County receiving \$100,000 and Senior Living Alternatives, Inc. / Holly Place receiving \$90,000.

 Words making up a charity's name closely resemble a more well-known charity.

Allowing you no time to reconsider your pledge. Refusal to answer questions about where your money

will go or refusal to mail information about the charity. - Emotional appeals that make you feel quilty about not donating.

- Bills or invoices sent to you, though you never pledged money to the organization.

How to spot charity scams that solicit donations over the phone: Get the exact name of the charity and the fundraiser

that is calling for the charity. Ask if the caller is being paid by the charity.

 Ask if the charity and the fundraiser are registered with the state.

- Find out where and how your donation will be used and what percentage goes directly to carry out the charitable purpose described by the solicitor.

Ask if the contribution will be tax deductible.

In his inquiries to the companies, Kerns said he asked for between 3,000 and 5,000 square feet in trying to get the most bang for the buck.

The price range would be in the \$350,000 to \$450,000 range, Kerns said.

Kerns is hoping to get costs and square footage from all the companies to see what the cost is per square foot and then be able to compare "apples to apples.'

Kerns noted the splash pad can be open while the pool is closed and likened that particular possibility to when the pool would be closed early for the day due to rain, and then the sun comes out. The splash pad could still be

"I think you'll find that a lot of people will enjoy the splash pad more than you think they will," Kerns said. "We're getting a lot of good reports from people that have them in."

Kerns said splash pads don't need lifeguards and fencing and that's one aspect of them that has to be considered.

Lanehart used the example of Park N Dine and it being reopened as a restaurant, since it is an established restaurant. If the owner wanted to use a shed to cook and serve out of, Lanehart said he'd have no issue with it since town bills and taxes are being paid for through the restaurant.

Kuczynski said he understood Lanehart's rationale, but didn't know if the Health Department would allow something like that.

According to the town's ordinance, permits can be obfor temporary structures like a storage or construction building, or a temporary concession stand. Kuczynski said that could arguably be a food truck.

Kuczynski noted the town does not have anything regulating food trucks as they typically are on the street.

This could allow for temporary permits and be applied for at least 14 days in advance. Temporary, as defined by the ordinance, is up to 90 days.

Kuczynski told town officials the ordinance doesn't allow for mobile homes or trailers to be used for residences or other daily uses, but there are exceptions.

Kuczynski gave the example of someone doing renova-

tions to their house; they can get a permit to have a storage container.

All temporary-use permits and exceptions can be viewed on the town's website.

Kuczynski noted that if someone owned an RV, they could store the vehicle on their property so long as it isn't occupied while in stor-

Kuczynski said officials would have to look at the town's zoning as well.

He said the ordinance itself is one of the "stingiest" ordinances he's seen.

There's also the possibility the town could revert the ordinance and start over, but town officials didn't make any movements on changing or repealing the ordinance on Monday.

While advertised as a public meeting where residence could voice their ideas and discuss the ordinance, out of the six people in attendance, only one signed up to speak.

April Davis, who spoke on the subject during the town's last special meeting on July 28, addressed town officials during this meeting.

Davis told town officials she might be wasting her time as they had already decided whom they would pick and choose to be allowed to

Davis said while she understands restrictions about using temporary buildings or RVs as dwellings, she doesn't agree with businesses not being allowed to conduct business out of them. A few have been doing so for a number of years, she noted.

"Hopefully this is a wakeup call that someone in charge should know all of our rules and enforce them in a timely manner so we don't end up in another situation like this," she said.

With those businesses established here and built a clientele. Davis said since they didn't leave, that loyalty should be considered with the ordinance and zoning amended.

She still wasn't sure why town officials are "closedminded" on food trucks and the only town in the county making it hard for them to be

One food truck owner attempted to purchase a building in town but it didn't work out, so they turned to the food truck, Davis said.

With the condition of the buildings in town, Davis said town officials should focus getting the owners of the buildings to higher standards to keep the town from looking like "an abandoned ghost town."







If you're looking for a good read at the beach or in that comfy arm chair in the air conditioning, check out some of these summer book

Elin Hilderbrand's novel The Hotel Nantucket is about a newly restored hotel which suffered a tragic fire in 1922 in which a 19-year-old chambermaid Grace was killed. After the fire the hotel became dilapidated over the years and was abandoned. Eventually a billionaire came forward and renovated it.

Clark is considered a suspect when a young man from town is found dead. The book was made into a movie that was released this year.

Grisham novellas

John Grisham, legendary legal thriller master, published three novellas in his book Sparring Partners. Homecoming has lawyer Jake Brigance of Grisham's A Time to Kill fame trying to help an old friend and former lawyer who fleeced his clients, divorced his wife, filed for bankruptcy and then disappeared into the night.

In Strawberry Moon, Grisham focuses on a young inmate on death row who faces execution in three hours. His
